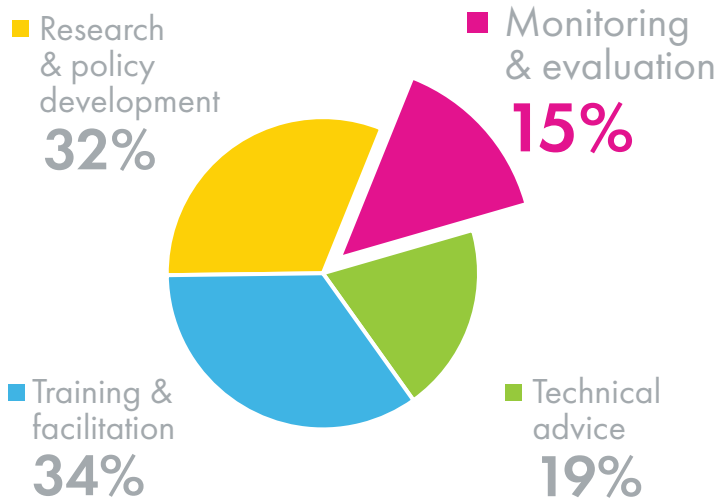

EXAMPLE OF RECENT PROJECT

In partnership with the Office of Development Effectiveness, Humanitarian Advisory Group recently co-led the evaluation of Australia's response to Cyclone Pam, producing the publication *Humanitarian Assistance in The Pacific: An Evaluation of the Effectiveness of Australia's Response to Cyclone Pam*. Humanitarian Advisory Group co-led the research in Vanuatu and the region, as well as production of the evaluation report.

This evaluation sought to review Australia's response to Cyclone Pam to identify how the Department of Foreign Affairs and Trade can better support Pacific Island countries to prepare for, respond to and recover from rapid-onset emergencies. When Cyclone Pam hit Vanuatu in March 2015, it was the most powerful tropical cyclone ever recorded in the southern Pacific region. Less than 12-months later Cyclone Winston, an even more powerful cyclone, struck Fiji. The Australian government provided humanitarian assistance following both cyclones, and, in the face of increasingly severe weather-related natural disasters, continues to support Pacific Islands to prepare for and recover from rapid-onset emergencies. It is essential that Australia identify how to improve the effectiveness of the humanitarian assistance provided in the Pacific.
